

## CDL Board Member Application Form

### What are the Requirements to be a CDL Board Member?

You must:

- be a member in good standing with any provincial or territorial Bar in Canada;
- have been a member of CDL for a minimum of three years;
- have a genuine interest in the mission and purposes of CDL;
- have a proven willingness to take on responsibility.

### What are the Responsibilities of a CDL Board Member?

*The CDL Board is a policy governance board that governs strategically by focusing on the future, allocating a majority of time on issues with long-term impact for CDL. Board members must understand and promote CDL's purpose and understand the challenges facing the defence bar. The CDL Board reflects our geographic diversity to ensure adequate national representation. A Board Member's term is three years after which you may either move to the Executive, or you may re-apply as a regular Board Member.*

### Specifically a Board Member is expected to:

1. promote CDL's image by serving as an ambassador
2. build a collegial working relationship with others that contributes to consensus
3. acknowledge the authority and responsibility entrusted to committees and staff
4. cultivate new leaders on the board
5. mentor new board members
6. prepare for and attend board meetings and committee meetings as well as other CDL meetings and events
7. volunteer for and willingly accept assignments completing them thoroughly and on time
8. be willing to represent your region
9. stay informed about committee matters, prepare well for meetings, review and comments on minutes and reports
10. actively participate in the board's annual evaluation and planning efforts
11. provide nominations for awards
12. assist committee chairs with local initiatives
13. provide regular communications to local members
14. recruit and orient new CDL members
15. canvass own firm for members
16. have your CDL affiliation shown on your firm's website
17. be prepared to give the About CDL presentation at events
18. select, support and assess the Executive Director
