Innovation Sandboxes: Developing Models for the Delivery of Legal Services to Improve the Existing Regulatory Framework

Multiple studies have shown that over 80% of Canadians with legal problems never consult a lawyer. To deal with these unmet legal needs, the Law Societies in Ontario, Alberta, Manitoba and British Columbia have each implemented Innovation Sandboxes, which temporally relax the rules to create safe spaces for innovators seeking to improve how law is delivered. The Sandboxes differ in approach and scope but share the common intent of encouraging the development of innovative entities that will deliver quality legal services in a way that is more accessible and affordable while being closely monitored by the Law Societies whose role is to protect the public.

This session will explore the reasons that led to the establishment of the sandboxes, the guardrails being used to protect the public, and some of the early initiatives that have come forward so far - including the use of AI and automated document creation, digital client identity verification, modified law firm structures, co-management and non-lawyer ownership, and modified roles for other professionals assisting lawyers or servicing needs not being addressed by lawyers.
